Disability workers provide personal, physical and emotional support to people with a disability who require assistance with daily living. Care is provided in the client's home, their community, and in residential care settings.

This qualification will equip you with the skills to support clients to meet their goals, and to empower them to participate in the community. There is strong growth projected for jobs in the disability and aged care sectors. The industry needs diverse, qualified, compassionate carers like you!

## Entry requirements

You will need a minimum level of skill in listening, speaking, reading and writing. Proof of COVID-19 vaccination is required.

The minimum age requirement is 17 years unless an exemption has been provided. You will need to apply for and receive a Police Check and Working With Children Check.

## Considerations

May be required to work evenings, weekends and rostered shifts. Required to be physically fit to carry out tasks. Understanding of cultural issues in attending to the needs of individuals is required.
