Course overview

The children's services sector is one of the most fulfilling career paths you can choose. As an early childhood educator, you will be sought after by employers, and have the chance to change the lives of the children you care for. From working in a childcare centre to running your own Family Day Care, there will always be a job opportunity available to you.

This course studies how to plan activities and provide care for infants, preschoolers and primary-school-aged children with appropriate use of policies and procedures within a range of early childhood education settings.

- Family day care educator
- Childhood Educator assistant
- Playgroup supervisor
- Nanny

Duration

Approximately 43 – 58 weeks including holidays (dependent on placement availability and school holiday dates). You will be expected to attend **class 1 day per week**. Recommended self-study time is a minimum of 10 hours per week.

Placement

You will need to complete a minimum **160 hours of placement which will be partly completed in our Early Learning Centres**. Practical placement is organised by New Futures Training. Refer to **FAQ** for more information.

Entry requirements

You will need a minimal level of skills in listening, speaking, reading and writing.

Proof of COVID-19 vaccination is required.

The minimum age requirement for this course is 17 years.

Considerations

The level of care will include assisting children with their daily routine, including eating, toileting, sleeping and dressing.

Required to stay on your feet for long periods, and lift children and equipment.
