### **Course overview**

The Certificate IV in School Based Education Support is a mid-level course that will support a rewarding career working as a teacher aide at a school. This qualification reflects the role of workers in a range of education settings, including public and independent schools and community education settings, who support teachers and students. During class you will have access to materials and equipment you would expect to see at a school, including Chromebooks and iPads.

### **Outcomes**

This qualification can lead you to job roles such as:

- Teacher Aide
- Teacher assistant
- Integration aide
- Learning support officer
- Education support worker
- Special needs education assistant

### **Delivery mode**

- Classroom-based
- Blended

### **Duration**

40 sessions over approximately 52 weeks including holidays, dependent on placement completion.

You will be expected to attend class 1 day per week. Recommended self-study time is a minimum of 10 hours per week.

### **Placement**

You must complete a minimum of **100 hours** total in a New Futures Training approved primary or secondary school. Refer to FAQ for more information.

## Entry requirements

You will need a minimum level of skill in listening, speaking, reading and writing to support students in a school.

The minimum age requirement is 17 years unless an exemption has been provided.

You will need to apply for and receive a Police Check and Working with Children Check

## Considerations

The course requires you to be able to assist diverse children and young people with literacy and numeracy as well as their emotional and physical wellbeing.

You will work with individual students as well as small groups.

Understanding of cultural issues in attending to the needs of individuals is required.
